  - Access to house rental properties

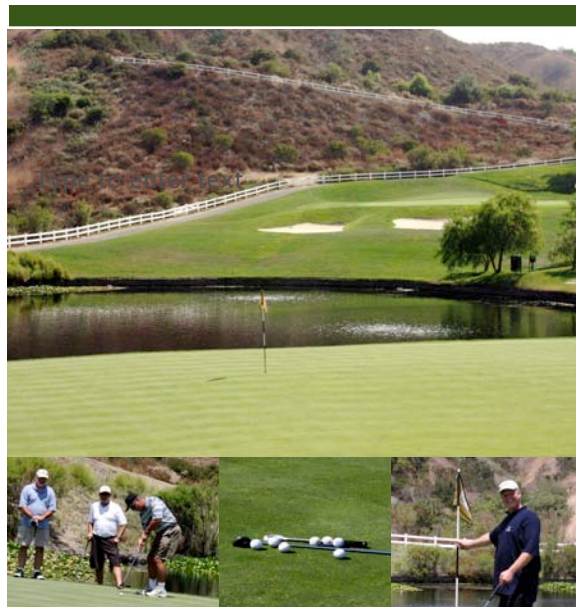
